As the New Orleans Saints prepared to play the Indianapolis Colts in last year's Super Bowl, Miami attorney Chris Lyons received two phone calls.

One came from former NFL star defensive line-

man Warren Sapp, and the other from Miami Dolphins defensive lineman AnthonyMcDaniel. Both had been charged with domestic violence. and both wanted

to be represented by Lyons.
Lyons was fresh off his representation of NFL wide receiver Donté Stallworth on a drunkendriving manslaughter charge, and his new clients knew he got results. Lyons dispatched his partner, fellow former Miami-Dade prosecutor Dan Lurvey, to McDaniel, while

he drove to meet Sapp. "That's when you know you are connected, that's when you know you got people out there saying, "This is the guy to go to," Lyons said.

Lyons knew then he had hit on a new business model for Lyons &

Lurvey, one that caters to the legal needs of professional, college and Olympic athletes, and not just in criminal court.

It could be as high profile as domestic abuse charge or a paternity accusation. Or it could be as mundane as drawing up a rental agreement or as crucial as reviewing a long-term free agent contract.

"The development of the sports concierge law firm resulted from

a commitment to a discreet and effective strategy to accomplish goals complicated by the client's unique position in our society,"

Lurvey said.
"There is an obligation in this type of representation to mediate an incredible number of interests not inherent in the representation of non-celebrity clientele."
